NOTICE INVITING TENDER

On behalf of the President of India Sealed Item Rate Tenders are invited by the Registrar, Mizoram University Aizawl, for the work of C/O Pavement works from Guest house to Commerce Building via Multipurpose Hall at MZU Campus, Tanhril Aizawl as per details given below:

The Tender document consisting of plans, specifications, the schedule of quantities of work to be done and the set of Terms & Conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be obtained from the Engineering Cell, Mizoram University Aizawl on payment of Rs. 500/- (Rupees five hundred only) in the form of Cash. The Tender Documents will be issued from **08th December 2009 to 05th January 2010 up to 1100 Hrs.**

TENDER CONDITIONS:

1. The Tenderer shall quote his rates as per prescribed proforma and as per the Terms and Conditions enclosed in the Tender document.
2. Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents and has made himself

aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the University and local conditions and other factors having a bearing on the execution of the work.

3. The Earnest Money Deposit (EMD) **Rs.1,79,128.00 (Rupees one lakhs seventy nine thousand one hundred twenty eight only)** mentioned above is absolutely mandatory and shall be enclosed along with the quotations in the form of Bank Draft / Banker's Cheque drawn in favour of the Registrar, Mizoram University, from a scheduled bank only.
4. Quotations should be valid for 30 days from the date of opening of the tenders and may have to be extended further if considered necessary by the University. No reasons will be assigned for extension and no withdrawal shall be allowed. If any tenderer withdraws his tender before the said period or issue of letter of acceptance, which-ever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the University, then the University shall, without prejudice to any other right or remedy, be at liberty to forfeit the said earnest money.
5. The time allowed for carrying out the work will be **5 months** from the 10th day after the date of written orders to commence the work.
6. No Telex/Telefax/telegram/E-mail of the Techno-Commercial and Price bids will be accepted. The University is not responsible for Postal/Courier delays. The parties have to ensure the receipt of bids well in time.
7. If the date of tender submission and opening happens to be unforeseen holiday, the same will be postponed to the next working day without any further intimation.
8. The University does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition put forth by the tenderer shall be summarily rejected.
9. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tender submitted by the contractors who resort to canvassing will be summarily rejected.
10. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
11. This Notice Inviting Tender shall form a part of the contract document.
12. The successful tenderer/contractor, on acceptance of his tender by the University, shall, within 5 days from the stipulated date of start of the work, sign the contract consisting of :- The notice inviting tender, all the documents including additional conditions, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.
